Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

The Vision of National Education Policy, to provide high quality education to develop human resources in our nation as global citizens, is well taken by our college. A discussion among the faculty members has been initiated on the key principles of NEP such as diversity for all curriculum and pedagogy with technological innovations in teaching and learning, encouraging logical decision making and innovation, critical thinking and creativity. The College is affiliated to University of Lucknow, Lucknow where in Academic programmes are redesigned to include Multidisciplinary /Interdisciplinary courses as electives and College started offering these electives to students. In order to provide the holistic academic

growth among students, Inter-disciplinary curriculum has been proposed which gives freedom to the student to choose their preferred options from the range of program offered by the institution. All the courses offered by College are Choice Based Credit System (CBCS). Few of (them also include value based and environment-based subjects like professional Ethics, Environmental studies, principles of Management, project management etc. All programmes are designed in such a way that students get maximum flexibility to choose elective courses offered by other Departments and MOOC through SWAYAM. It can be said that the college is proactively working towards implementation of the suggestions given in the NEP Guidelines. College has 3 courses namely B.Sc., B. Com and B.Ed., All the students are free to interact with each other. To make education more experiential, holistic, integrated, inquiry-driven, learner-centered, and flexible the cocurricular activities are conducted involving all the students of different disciplines. There are some value added and certificate courses like spoken and communicative English, Basics of ICT, Yoga and Meditation, etc. these courses are open for all the disciplines. The classes of these courses are conducted on regular basis and the students of different disciplines can get enrolled for it.

2. Academic bank of credits (ABC):

Our College preparedness in implementation of Academic Bank of Credits conforms to the guidelines of the affiliated university, University of Lucknow, Lucknow. University of Lucknow, Lucknow being state university is an official member of the National Academic Depository which is a government endeavour to offer an online repository for all academic awards under the Digital India Programme. From 2023 onwards, University of Lucknow, Lucknow is in the process of uploading students' mark sheets and degree certificates through the nad.digitallocker.gov.in platform through its affiliated colleges. The National Academic Bank of Credits (ABC) portal has now been integrated into the NAD portal https://nad.digitallocker.gov.in platform and is currently live from academic year 2023 onwards. University of Lucknow, Lucknow follows a choice-based credit system (CBCS) for all its programmes and is now in the process to pass a resolution related to the ABC in the Academic

Council. The Academic Bank of Credits facility introduced by the Government of India in NEP 2020 will digitally store the academic credits earned by the students of various higher education institutes across the country. Academic Bank of Credits id created by students' will enable their academic credit calculated on the basis of their class response, assignments, internal and external assessment to be stored online. It is just like bank for academic purposes with students as account holders to whom, the ABC shall provide a variety of services including credit verification, credit accumulation, credit transfer/redemption and Degree authentication. It aims to fulfil the students' inquisitiveness for knowledge and education by providing a system where students can choose their own learning path to attain a Degree/ Diploma/PG-diploma etc., working on the principle of multiple entry and exit as well as at anytime, anywhere, and any at any level of learning. The State Government of Uttar Pradesh has also recognized ABC as a foundation for implementation of multi-disciplinary Education, enabling an ecosystem which offers more flexible career choices to students. College has been informed by the university about the necessary action regarding an implementation of ABC. We have a dedicated team of faculty members, entrusted with the responsibility of implementation of NEP who from time to time attends workshops and training programs organized by the affiliating University, UGC and Higher Education Dept. and Government of U.P. With their guidance and support, class teachers have not only made students of all the years enrolled in various programs aware of the importance of ABC and its registration process but also extended all the support for opening accounts in Digi locker and ABC to understand the provisions of NEP so that same can be communicated and explained to the students and teachers for making implementation process simple and effective.

3. Skill development:

In an increasingly dynamic environment, we strive to develop the new generation students to live purposeful life with positivity and confidence. To instil human values, the college curriculum aims to provide value based education as to promote students' overall development along with building students character by conducting various activities

from time to time. We follow the systems of Teaching Projects based Assignments, Quizzes, Debates and Literary Write-ups. Students of B.Sc., B.Com and B.Ed. actively participate in all these activities. In-house seminars are regularly organized. Distinguished Guest-Speakers are invited from different walks of profession to deliver the lectures so as to keep the faculty and staff updated about world arena in different fields. To strengthen students' skills various training programs on Tally, GST, Life skills, etc. are also organized. Moreover, NEP has opened huge learning opportunities by integration of vocational education with general education. In line with this, our college took an initiative of developing the curriculum of value added courses such as – Basics of Computers, nutrition and wellness, Life skill and personality development, personal financial planning, E- Commerce, customer service skills etc. The IQAC cell actively participates to strengthen technical, vocational, soft skills of the students. The college has an established placement cell which actively participates to strengthen the current trends required in industry, Campus Recruitment Training (CRT) etc. The college is already conducting the skill courses as designed by affiliating university from Semester III to VI in various programs. Also, under the employability enhancement program for student in skill courses, the college has already been running courses such as soft skill development etc,

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The Sri Krishna Dutt Academy, affiliated with the University of Lucknow and prioritizes fair and transparent assessment practices, recognized by the National Council for Teacher Education (NCTE).

Our undergraduate program, aligned with the **Choice-Based Credit Framework since 2018**, offers personalized learning with 80% semester-end exams and 20% internal marks. This allows students to pick courses aligned with their interests and career goals, offering a more personalized learning experience. We alternate between subjective and objective exams each semester to maintain fairness.

The transition to the New Education Policy in 2021 by the University of Lucknow emphasizes continuous evaluation with internal assessments carrying 25% weightage, maintaining 75% for external assessments.

In our B.Ed. program, thorough assessment includes written exams (80%) and internal marks (20%), ensuring graduates are well-prepared for successful careers in education.

Mechanisms for Transparency and Fairness:

At the conclusion of the internship, students are required to submit a compiled project report that reflects their experiences and learnings during the internship period. This report is evaluated based on criteria such as presentation skills, the quality of the project content, and the student's ability to articulate their learnings effectively.
